State Budgetary Impact of Additional Medicaid Enrollment Over 16 Months

From Medicaid Calculations Workbook

Based on state Medicaid enrollment levels for September 2020 and February 2020. Difference in enrollment was multiplied by a 2019 estimate of annual per-enrollee costs to get an annual estimate of state fiscal impact. Finally, based on assumption that the pandemic will continue through June 30, 2021 –for a total of 16 months—multiplied the annual cost impact estimate by 16/12.

Benefit of FMAP Enhancement Over 18 Months

The federal government is picking up an additional 6.2 percent of Medicaid costs from January 1, 2020, through the end of the public health emergency, which is now set for March 31, 2021. Assumes that this will be extended through June 30, 2021, and thus provide an estimate that is 6.2 percent of total state Medicaid costs per year multiplied by 18/12.

The CARES Act provided \$150 billion for state, local and territorial governments. State and local allocations have since been documented by Department of Treasury.

Municipal Liquidity Facility—Estimated Interest Subsidy

Only general purpose government to take loans was Illinois. Assuming one percent of the \$3.2 billion borrowed. Only two governments took advantage of the Fed's Municipal Liquidity Facility. One—the New York Metropolitan Transportation Authority—is not a general purpose government and is thus excluded. Illinois borrowed a total of \$3.2 billion from this facility, but could have borrowed that amount on the municipal bond market, most likely at higher interest rates. The estimate provided assumes that Illinois saved one percent on its borrowing by using the Fed.
